# Minutes of the Meeting of Denby Dale Parish Council held on Tuesday 6 October 2015 in the Civic Chamber, Council Offices, Skelmanthorpe

## 15/063 Chairman's Opening Remarks

Cllr Cook welcomed the councillors to the meeting.

### 15/064 Declarations of interest/disclosable pecuniary interests

There were no declarations of interest.

## 15/065 Open Session

Christopher Ward spoke in support of the grant application submitted by the Parkgate Sports and Community Trust and thanked various members of the council for their support. Kevin Hill, a resident of Skelmanthorpe, spoke to the meeting regarding anti-social behaviour in the village and nearby woods. The Caretaker of Skelmanthorpe First and Nursery School spoke to the meeting regarding damage around the school area and evidence of drug use.

### 15/066 Apologies

Apologies were received from Cllrs Blanshard and Summers. Cllr Banawich was absent. **RESOLVED** that the reasons submitted be approved.

## 15/067 Police Report (brought forward)

PS Marsland informed the meeting that the police were aware and were acting on the anti-social behaviour in the village, and that due to cuts in the service and changes occurring at the moment, less resources were available. From February the ward would be covered by a Ward Manager, supported by PCSOs. She emphasised the need for reporting of issues, via the 101 number, which recorded the information in an evidence log for historical purposes, or via email, which were not kept historically, or by looking on the website for the 'contact us' icon. The Clerk was asked to publicise these in the newsletter. Cllr Turner reported that he had seen a high police presence in the village at the weekend, and also re-iterated the need for public to ring in and report issues. Cllr Denby asked about the Neighbourhood Watch and PCSO reduction. PS Marsland stated that Mark Wall was leaving and would not be replaced, and that following consultation with local watch teams, it would be the new Ward Managers who would be responsible for this in the future.

## 15/070 Ward Councillor's report

Cllr Turner gave a verbal report:

- The library report had gone to Cabinet on the 22<sup>nd</sup>, and would be sent to the Scrutiny Panel on the 23<sup>rd</sup> October, after which it would be active if approved. For Skelmanthorpe, this would mean one member of staff for 15 hours per week with volunteers.
- A very successful deal had been struck around Broadband, and a postcode checker was now available for residents to check their connectivity.

- Little was happening around the Budget, as Kirklees were waiting for the Autumn Statement from Government to hear what their settlement would be, it would possibly be January before this was known.
- By Christmas, in line with Government policy, there would be refugees in the Kirklees area with a 2 year support package from the Government.

**RESOLVED** that the report be received.

# 15/071 Report from Andy Wickham, Countryside Officer (Kirklees Rights of Way Forum Brought Forward)

Andy Wickham provided a written and verbal report.

A discussion was held around volunteer action in the area, Andy stated that Kirklees were looking into various legal issues, issues on risk assessments, PPE...and the need for a structure to be put in place initially. This needed to be done without putting people off volunteering however. Cllr Brook stated that with the reduction in Public Rights of Way, the Walkers are Welcome group were doing low level path maintenance which would hopefully be expanded but this depended on volunteers coming forward. Andy stated that any issues at the moment should be reported to Kirklees, who would refer them to the Walkers are Welcome Group to see if they could assist. Kirklees would still undertake any enforcement necessary.

## 15/072 Clerk's Report

- <u>Denby Dale Station</u> Cllr Depledge advised she had contact from Andy Manning at Naylor's who had discussed gifting a piece of the site to the Council. A meeting would be set up with them to discuss the plans further, when Naylor's would be requested to attend a Full Council meeting to clarify their proposals.
- <u>Land at Upper Cumberworth</u> Cllr Cook requested that as no progress could be made that this item be removed from the Clerk's report.
- Overhanging Branches Cllr Turner advised that the relevant legislation was held in the Highways Act 1980 s154.

#### 15/073 Vacancy in Skelmanthorpe Ward.

The Vacancy in Skelmanthorpe Ward was formally reported, with procedures in place for cooption.

Cllr Brook reported that 100 people had visited the Textile Heritage Centre during the Heritage National Open Days in September. He also reported interest from History Department at Huddersfield University in forming a possible partnership. Cllr Brook also distributed flyers advertising the latest EPIP Leader Programme grants.

### 15/081 Denby Dale Community Project Update

Cllr Brook reported on progress on the now single storey building, with the next public meeting to be held on Monday 19<sup>th</sup> October at 7.15pm. He reminded councillors that to date, of the £40,000 committed by the council to the project, £18,000 had been drawn down, the balance of £22,000 be drawn down when construction starts.
