## 15/014 Declarations of Interest

## 15/016 Apologies for Absence

Reasons for absence from the meeting were submitted from Cllrs N Denby and S Hellewell. **RESOLVED** that the reason for absence submitted by the councillor be accepted as valid.

## 15/017 Admission of the Public

**RESOLVED** that there were no items requiring the exclusion of the press and public.

## 15/018 Budget 2015/16 and Expenditure Review

The current outturn was discussed, Cllr Brook advised that another schools grant application had been received. It was agreed that the Clerk should circulate the breakdown of election expenses once received. **RESOLVED** that the expenditure review be accepted.

# 15/019 Draft Budget 2016/17 and Preliminary discussion on Precept

It was **RESOLVED** that the allotments fund should be increased by £10k, as this fund was set several years ago and costs had now increased. Cllr Depledge stated that following a meeting with Naylor's concerning the land at Denby Dale station, it was clear that there was much work to be undertaken by Naylor's around the quarry, and that this would probably not impact on next year's budget, but may be a factor in the future. It was noted that the precept could not yet be set until final figures were provided to Kirklees Council regarding the Council Tax Reduction Grant, which would not be until December.

**RESOLVED** that the draft budget be recommended to Full Council with the amendment to the allotment fund.
